Kent Island Scuba takes no responsibility for injuries resulting from the use of condemned equipment. Records of all condemned equipment will be maintained and will be provided at the time of any dive incident/accident.

Kent Island Scuba recommends that all equipment be thoroughly inspected and tested for safety and proper operation prior to each dive.

I understand and agree that Kent Island Scuba makes no guaranty, representation or warranty including any implied warranty of merchantability or fitness for particular purpose with respect to the diving equipment serviced.

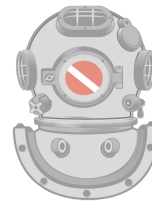
